Working to Ban Legislative Non-Profit Organizations

Pennsylvania legislators will be banned from creating their own non-profit organizations if legislation that I've authored is signed into law. My bill passed in the House by a vote of 195-1 earlier this session and now awaits consideration in the state Senate.

The point of my bill (House Bill 109) is very clear: legislators should not be permitted to create or maintain entities that allow them to spend tax dollars at their discretion. There have been some problems with this type of action in the past, and this bill will help to clean up this issue.

I first introduced this legislation in 2007 and again in the 2009-10 legislative session, but legislative leaders never brought the bill forward for committee consideration. Provisions of my bill have been included in internal House rules in both the 2007-08 and the 2009-10 sessions, but that action simply doesn't go far enough.

I've been pressing the issue with this bill so that the prohibition of legislative non-profits is permanent, and applies to both the House and the Senate. This is all about accountability and transparency for our tax dollars.

My bill is part of the most significant package of reform legislation that the House of Representatives has considered in more than a quarter of a century.

The people in my district, and people all across Pennsylvania, have made it clear that they want change in how Harrisburg operates. My bill is just one of many steps that can and must be taken so that the public can have restored trust in state government.

Property Tax/Rent Rebate Program Applications Are Now Available

Forms for the state's Property Tax/Rent Rebate program for 2010 are now available at my office.

You can visit my office at the Beaver Falls Professional Center, 1122 Seventh Avenue in Beaver Falls, or download them directly from my Web site at RepMarshall.com.

Eligible participants can receive a rebate of up to \$650 based on their rent or property taxes paid in 2010. The program benefits eligible Pennsylvanians who are 65 years or older, widows and widowers 50 years or older, and those 18 years or older with permanent disabilities.

Eligibility income limits for homeowners are set at the following levels, excluding 50 percent of Social Security, Supplemental Security Income, and Railroad Retirement Tier 1 benefits:

- \$0 to \$8,000, maximum \$650 rebate (Homeowners and renters)
- \$8,001 to \$15,000, maximum \$500 rebate (Homeowners and renters)
- \$15,001 to \$18,000, maximum \$300 rebate (Homeowners only)
- \$18,001 to \$35,000, maximum \$250 rebate (Homeowners only)

The Property Tax/Rent Rebate program is one of many initiatives supported by the Pennsylvania Lottery, which dedicates its proceeds to support programs for older Pennsylvanians. Since the program began in 1971, more than \$4 billion has been paid to qualified applicants.

Residents are reminded to provide all the necessary income, property tax or rental information required to process claims quickly and accurately. Applications are due by June 30.

Tis the season! Here's a Way to Let PennDOT Know About Potholes

To report potholes or other road concerns, feel free to contact my Beaver Falls office at 724-847-1352. You may also report potholes located on state roads directly to the Pennsylvania Department of Transportation (PennDOT) to report it at 1-800-FIX-ROAD (1-800-349-7623).

Please be as specific as possible when reporting pothole locations. When reporting about state routes, please be prepared to provide the county, municipality, street name, or preferably the state route (SR) number found on small, black-and-white signs posted along state roadways. When possible, offer a description of any familiar landmarks that will help PennDOT find the problem area.

The hotline may also be used to report maintenance concerns other than potholes, such as deer removal or signage issues.

Once notified, PennDOT will work to quickly address concerns when weather permits.

To report potholes on local roads, motorists should contact the municipality in which the pothole is located.

Potholes develop when water seeps below the road through small cracks in the pavement surface. As the water repeatedly freezes and thaws, a cavity below the road is formed and larger cracks develop, causing the pavement to crumble.
